Report Summary	This report summarises the activity of the chair since the last board meeting.

Much of my time since my last report from our November board meeting has been spent leading the delivery of Transport Planning Day 2022, getting ready for the AGM and arranging a smooth handover to the new incoming chair.

This report also summarises other engagements I've undertaken in the capacity of Chair.

TP Day 2022 Update

The 2022 TP Day event at ICE went well I thought, bringing together a wide range of thought leaders from across the industry coupled with an engaging discussion on representing the views of different generations in transport planning decision-making. I particularly enjoyed the presentation by Rhiannon Hardiman providing a summary of the Welsh Future Generations Act and its impact on transport policy and the lively discussion this then led to across our inter-generational panel.

It was also a joy to be back in person at ICE, and I confess to a genuine warm glow of a job well done as delegates filed into the suitably grand reception room after the last session to enjoy a glass of wine and a nibble, providing mood music of animated chatter about the content of the day, and occurrences in the sector in general. When planning the event, we weren't sure whether we had provided too much time for informal networking, but my feeling is that this side of things is really a key purpose of the Society and is as important as the content in the main session.

22 November – Transport Scotland Meeting (Stephen Cragg)

It was good to catch up with Stephen about developments north of the border and how TPS can get more involved. It's clear that the 20% traffic reduction target is focussing minds, and leading to some interesting policy discussion - particularly around the role of digital accessibility in facilitating sustainable growth.

24 November - Interchange Steering Group

I represent TPS and ICE at this steering group for the Interchange conference and media platform. I think it's a really interesting initiative which seeks to break down modal silos and transmit learnings across the industry – a key function of TPS and the transport planning profession generally of course! 30 November – Low Traffic Future Discussion with Roger Geffen

I had a conversation with Roger Geffen about the new 'Low traffic future' alliance. See more here: Low Traffic Future The alliance is intended to draw together stakeholders with an interest in sustainable transport to better articulate the benefits of reducing traffic volumes. Clearly, this is a timely initiative given all the recent social media furore around 15 min cities, LTNs and the like. TPS is not a formal supporter of this (as a body representing the profession, we don't typically back individual campaigns) but I have agreed we would offer to disseminate work by the alliance and provide a platform for their research and insight as appropriate.

6 December – National Infrastructure commission Round table (ICE)

I attended a very interesting roundtable exploring the next national infrastructure assessment (NIA) by the National Infrastructure Commission which is just kicking off.

This is a huge and fascinating cross-cutting piece of work across all infrastructure sectors, but it was obviously particularly useful to get more information on the areas of focus with relevance for transport planning.

Looks like there will be some very useful work on how to improve urban transport. The role of mass transit in delivering improved competitiveness and productivity will be explored, and it was good to hear that there will now be consideration around the role active travel can also play in this space - a key recommendation in the Transport Planning Society feedback to the consultation on NIA earlier in the year.

Perhaps most excitingly there is a specific focus on exploring demand management options in cities as a way to counter congestion - what role could schemes like workplace parking levy or congestion charges play in delivering wider objectives (e.g. well being), and, crucially, how best they can be facilitated through existing governance structures.

A second stream considers inter-urban corridors.

The focus here seems to be on ensuring that infrastructure is fit for purpose in delivering growth, including levelling up. Very welcome discussion on taking a multi-modal approach to this, and the idea (I think) of developing a framework that could help allocate funding across modes in the light of wider objectives. I thought that sounded a bit like a national transport strategy...

I made the point that there was no demand management focus within this package - with the response being that congestion on inter-urban corridors was perceived as less of an issue and hence the focus needed to be on connectivity. I'd question that assumption - if we are looking to improve travel times between economic clusters to support productivity gains and agglomeration benefits (for example) - helping to optimise and ensure the most efficient use of existing infrastructure should be the focus#1, before enhancing or building new infrastructure. And there also needs to be a recognition of induced demand that will inevitably result if capacity is increased without corresponding controls on the use of that new kit.

Also, the key is to think that managing demand doesn't always have to mean road pricing. It could be around measures to increase car occupancy, facilitate digital access to services to reduce the need for travel, explore the potential of social movements like a 4-day week, integrate land use and planning etc...

Finally - very welcome discussion around resilience and news that there will be a deep dive into asset management and maintenance - including for local roads. The question posed - are pothole funds really the best way of managing this vital asset? (Spoiler: No.).
